

Amendments to Chapter Ten (Intellectual Property)

[1.] Article 10.23 (Addition of Geographical Indications for Protection) is hereby replaced with the following:

“ARTICLE 10.23

Amendment of the List of Geographical Indications for Protection⁸

1. The United Kingdom and Korea may enter into consultation to add geographical indications to be protected to Annexes 10-A and 10-B in accordance with the procedure set out in Article 10.24. Such consultation shall consider the Parties’ interests and sensitivities concerning the protection of geographical indications.
2. A name may not be registered as a geographical indication where it conflicts with the name of a plant variety, including a grape variety, or an animal breed and, as a result, is likely to mislead the consumer as to the true origin of the product.”

Amendments to Annex 10-A (Geographical Indications for Agricultural Products and Foodstuffs)

[1.] Part A of Annex 10-A (Geographical Indications for Agricultural Products and Foodstuffs) is hereby replaced with the following:
